Valeo Service, the leading provider of automotive supplies, has optimised sales administration with Esker DeliveryWare

Lyon, February 17th, 2004 – Valeo Service France, the Valeo division responsible for the independent automotive replacement parts resellers, has chosen Esker's document delivery solution, Esker DeliveryWare, to automate order confirmations and optimise its sales administration processes. This recent project brings to eight (5 in Spain and 3 in France) the number of successful Esker DeliveryWare deployments in the Valeo group.

Valeo Service receives between 1,000 and 1,500 orders daily from France and worldwide. When entered into Valeo's SAP system, the customer requests result in order confirmations that verify that order processing has started, describe the products ordered, and list any items that will not be dispatched in a delivery.

Valeo Service wanted a solution that allowed it to completely centralise and automate sending order confirmations. To solve this problem, Valeo Service installed Esker DeliveryWare. Using predefined rules, Esker DeliveryWare retrieves documents directly from SAP and distributes them automatically in the appropriate media, either fax or email, without manual handling.

The solution ensures equally intelligent distribution and follow up of order confirmations (sent by fax by default, sent by email, producing a follow up) guaranteeing Valeo Service better reliability and traceability. Other sales administration documents, currently processed manually, will be handled by this solution.

"Thanks to Esker DeliveryWare, many documents previously manually printed and faxed are now sent automatically from our information technology systems. Esker DeliveryWare was implemented in 4 days without modifying existing enterprise applications or business processes.
